Challenges

- have to accelerate the competitive success of European SMEs in Health Tech, Smart City and Greentech and have the potential to support SMEs and start-ups in scaling their solutions globally.
- must have the potential to result in a new (or significantly improved) product and service with higher value (e.g. higher quality, increased access, be eco-innovative, resource-efficient, internationally scalable)

Challenge Owners

- must be willing to engage in the project and have potential to implement the solution.
- must provide good quality information and data to support on the challenge.

Title of the challenge*: (70 characters)

- ① A catchy title, that expresses well what the challenge is about, will increase the chances that the challenge will be selected.

Short description of the challenge*: (300 characters)

- ① Short summary of the challenges: What is it about? Why is a solution needed and by whom? Why has the problem not been solved yet/why is this challenge new? (e.g. changes in legislation, advance in technologies)

Five keywords describing the challenge*: (5 keywords to be typed in)

Market potential (200 characters):

① Further information on application ideas for potential solutions, including estimation of market volume for the solutions, potential other users of the solution, other relevant markets/stakeholders; localisation and relevant regulations; risks and costs can be provide here. The more hard facts and data are provided, the better.

Timing (200 characters):

① When is the solution needed? All matters regarding the maturity of the challenge, how soon solutions are needed or when the challenge owner is ready to proceed, can be added here.

Type of solution*:

① Which type of solution is needed/welcome/useful? This is really critical information for the "solution providers" (SMEs/start-ups).
